Conditions Applying to Social Members

- All members must comply to the Morningsong Bowling Club Code of Conduct (available on the Club's web site; www.morningsongbowlingclub.org, under LINKS)
- Must ensure if they invite visitors or guests that they are the responsible person to enforce the club's Code of Contact and vaccination requirements.
- Must renew their membership on April 1st each year by filling out the form below and paying the membership fee within 30 days.
- Social members are not eligible to vote at MBC meetings.
- Social members are not entitled to Bowl unless
 - The Club organizes specific events to encourage them to take up bowling or
 - Undertake lessons with the view of becoming a bowling member.

The Procedure

- The Board reviews all membership applications. If successful, the Membership Officer notifies the applicant of the Board's decision and seeks payment of fees.
- When fees are paid you will be issued with a Social Membership Card and welcome letter. The club's handbook is online under the Member Tab on the club's website.
- Your name and phone number will be inserted in the club's online Member Contact list unless you advise the club you do not wish your name and phone number to be released. The Member Contact List is under the Members Tab, is password protected and available only to members.
